Chancellor Vincent Marsala has 37 years experience at LSUS and 36 years of administrative experience. Provost Stuart Mills has 31 years experience at LSUS and 20 years of administrative experience. Vice Chancellor Gloria Raines has 22 years experience at LSUS and 31 years of administrative experience. Vice Chancellor Michael Ferrell has 27 years experience at LSUS and 27 years of administrative experience. The Vice Chancellor for Development retired in March 2004, and the position is filled on an interim basis.
