BESE approved the removal of the requirement of a core academic skills assessment (e.g. Praxis Core) for both entrance into a Teacher Preparation Program and for licensure. In addition, the minimum GPA required for admission into the program is now 2.2 based on BESE's adopted policy to align with the legislation that requires a 2.20 GPA on a 4.0 scale for entrance into a teacher preparation program. The Louisiana Board of Elementary Education's Bulletin 996: Standards for Approval of Teacher Preparation and/or Educational Leader Preparation Programs states that all Traditional Teacher Preparation Programs must have candidates complete a one-year residency in a public or approved non-public school classroom in the certification area with a teacher of record who holds a valid level 1, 2, 3, type A, or type B teaching certificate in the area for which the candidate is pursuing certification. Alternative programs may also offer this as an option. For certification in B-K, PK-3, 1-5, or 1-5 integrated to merged, candidates must spend a minimum of 80 percent of the residency school site's instructional time each week engaged in residency activities. For certification in K-12, 4-8, 6-12, 4-8 integrated to merged or 6-12 integrated to merged, candidates must spend a minimum of 60 percent of the residency school site's instructional time each week in the first semester and 80 percent of the residency school site's instructional time each week in the second semester engaged in residency activities. Teacher preparation providers may seek approval to offer an innovative residency model that does not meet the minimum instructional time requirements but meets a specific workforce need and includes high-quality clinical experiences throughout the program and intensive clinical experiences throughout the residency year.

We continue to provide special education training to all candidates and the opportunity to become SPED certified upon graduation. We updated our Recruitment Plan, which addresses workforce needs and increasing participation in our programs. We have continued our partnerships with community stakeholders such as our Cybercollaboratory, Junior Achievement, and the Sci Port Discovery Center as well as with existing and new Charter schools to bolster opportunities for candidates to gain experience with learners in multiple settings.

All Education courses include a technology component beginning with our 200 level courses through Residency. In Education 202, our students utilize google products for collecting and analyzing data and achieve Level 1 certification. Our plan is to ensure students are Level 2 certified by the time they complete the program. The 200-level course will embed computer science K-12 content standards, an overview of computational thinking and computer science content, and standards-based instruction based on the core concepts and practices found within the Louisiana Computer Science Framework. All 300 and 400 level methods courses have a technology requirement and, in some classes, more than one, where students are engaged in preparing and implementing lessons using different kinds of technology. Our Clinical Experience is heavy on technology. Students in Residency have access to district systems such as Illuminate and JPAM for use in collecting, managing and analyzing data. The Work Sample required in Residency 1 requires that students conduct pre/post testing, analyze and interpret data to note impact on student learning. Faculty members have expertise in the principles of universal design for learning and this has become a part of our preparation. Technology courses have been redesigned within the last 3 years which helps to ensure continued accreditation with technology standards. We have built a technology matrix that cross references where and when technology is included in all education courses so that we can better monitor differentiation of experiences for our candidates. Assessment circles are held several times a year to review data and discuss areas for continuous improvement.

Teacher Training

a. Teach students with disabilities effectively

Candidates have a Louisiana Individualized Education Program (IEP) broken down into its components and are given actual classroom examples and models of how specific accommodations and/or modifications should be implemented, and their impact on student learning and performance. Candidates are taught the foundations of innovative, evidence-based instructional design frameworks, such as Universal Design for Learning. Then candidates are given multiple opportunities to practice said instructional designs within their own practice through content presentations with their colleagues. Following content presentations students are required to reflect and analyze how their implementation of their use of the strategy and/or (if they are not the presenter) the content itself and how their new knowledge will impact their classroom practice. Candidates learn how to assess and teach skills/strategies related to all subject areas and across all grade levels. Also, the candidates are given opportunities to research high-incidence disabilities and their impact on student learning and performance. Candidates write lesson plans that take into consideration the different learning needs of students and how they will be addressed through differentiation and the use of accommodations and/or modifications. Candidates also learn how to give assessments and interpret the resulting data to determine student strengths and weaknesses and then develop lessons based on students’ needs. Candidates develop an understanding of literacy development theories, research, and effective instructional practices, and how they can be used to inform and promote reading, writing, and oral language development in typically developing children as well as those who find learning literacy difficult and/or are acquiring a second language.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Candidates develop an understanding of the MTSS/RTI framework and the teacher’s role in the process, which includes an understanding of the Special Education Referral process including participation as a member of Individualized Education Program (IEP) Teams. They take a class focused on learning the skills and strategies to use when working with the people who make up an IEP team, such as special education teachers and especially families of students with disabilities. They are encouraged to interview a practicing general education teacher in their grade level of choice to inquire about what it is like to be on an IEP team from their perspective, and best practice looks like in those situations.

c. Effectively teach students who are limited English proficient.

Candidates develop an understanding of the needs of English Language Learners (ELL) across all areas of Language Arts and Literacy and how to support these learners as they develop their skills in English. Candidates must address diversity in the classroom and include mentor texts that are inclusive of the cultures and languages of students that might be in their classrooms. They also develop an understanding of the difference between ELL and a specific learning disability. Furthermore, candidates are taught different methods for communication and collaboration with the parents of ELL students, and the support staff that may be servicing them in the general education environment.
